**With this change, my current office location at Lafayette Gastroenterology will close business on 4/28/2024 and I will no longer be seeing patients at Unity Healthcare.** I will not have any access to the Follow My Health (FMH) patient portal. This change means you have a decision to make. You have the right to choose your health care provider, and I am committed to fully supporting your decision. Your primary care physician should already have all my records. You are welcome to discuss your options with your primary care physician. You can:

1. **Stay with me as your gastroenterologist:** You can do this by calling the scheduling desk at 765-448-8100, beginning April 29, 2024. You will need your insurance card(s) and driver's license with you when you call. You can continue with your current primary care physician. Records can be picked up for free from our office between 1-3:30 pm until April 23, 2024. You need to call our office after 4 pm (3 business days in advance) and leave a very brief voicemail providing your full name, spell it out, telephone number and date of birth. You will need to sign a medical release form when you pick them up. You are also able to complete "Release of Medical records" form on our website [LafayetteGastro.com](http://LafayetteGastro.com) and email to [lgpatients@unityhc.com](mailto:lgpatients@unityhc.com), to receive your records by email or fax. Shipping and handling fees will be charged if you request them to be mailed and must be paid in advance.
2. **Stay with Unity Healthcare:** If you would like to continue your gastroenterology care with Unity Healthcare, please call 765-807-2787 for an appointment. They have access to all my records.

I want to take this opportunity to express my heartfelt gratitude for your trust and loyalty as a patient. It has been a privilege to serve you at our current location for the last 18 years, and I am excited about the opportunity to continue our patient-physician relationship at our new address.
